

PRO BONO WORK IN CONNECTION WITH NACDL

People v. Chelsea Becker:

As a member of the WICD Committee, in late 2019, then-president Nina Ginsberg asked me to assist Chelsea Becker, a King's County woman in the remote, rural Central Valley of California, who had been charged with murder for the death of her full-term fetus. I undertook this impactful reproductive rights case *pro bono*, together with Lynn Paltrow of NAPW, and NACDL Board Member, Dan Arshack. After litigation of several motions, multiple interlocutory appeals and a preliminary hearing, we obtained the dismissal of her case, followed by the ousting of the District Attorney. *See*, for example:

In re Adora Perez:

Upon representing Ms. Becker, I learned that she was the second woman charged with such a crime in connection with the death of her fetus. The first, Adora Perez, was serving her fifth year of an 11-year sentence. My colleague and I obtained Adora Perez's file, and, again alongside and , consulted weekly with the appellate team who, after more than a year, ultimately freed Adora Perez. *See*:
